It shall be within the discretion of the Headmaster or his representative to punish or dismiss my son for breach of any such rules, regulations, or policies.

I also agree to cooperate with Academy authorities in the maintenance of good discipline and do hereby consent to the administration of drug screen tests to my son if deemed necessary by the Academy authorities. Refusal of a drug screening test by a student shall be considered grounds for dismissal (the Academy has been advised that a drug screening test can establish that there has been drug use, but it cannot insure that there has been no drug use).

I am enclosing the \$100.00 non-refundable Application Fee and agree to pay the balance before June 8, 2012. I also understand that in the event of dismissal or withdrawal, there will be no refund other than money deposited with the Academy for student allowance. Additionally, students will be charged for medical services provided, damage to property and/or books, or other extra services. The Academy will bill me separately for those charges.

I further agree that Camden Military Academy has the right to withhold student transcripts and/or records until all financial obligations are met. In addition to the above agreement, I also agree that photographs taken of my son/charge while a student at Camden Military Academy may be used in school sponsored publications, advertisements, and commercials.
